



## Marine Notice No. 39 of 2023

*Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers,  
Yachtsmen and Seafarers*

### Seven Heads and the Old Head of Kinsale Deployment of benthic sensors

#### 1. Notice of Activity

The Department of Transport has been advised by the School of Biological, Earth and Environmental Sciences, University College Cork that they have deployed **12** benthic sensors **on 12 June**, between the **Seven Heads and the Old Head of Kinsale**. This research aims to track skate using acoustic tracking equipment. The benthic sensors will be deployed for 12 months.

#### 2. Location of Activity

A map detailing the locations and a table of coordinates for the benthic sensor's deployment positions are attached at Appendices 1 and 2. Each sensor consists of a mooring weight and an acoustic sensor for tracking tagged skate in the area. Each sensor has no surface marker.
