



## Marine Notice No. 38 of 2022

*Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers,  
Yachtsmen and Seafarers*

### French Military Exercise

#### 1. Notice of Activity

The Department of Transport has been advised by the Irish Aviation Authority (IAA) of a missile/rocket firing exercise by the French military in part of the Irish Exclusive Economic Zone (EEZ) to the South-West of Ireland. The exercise is scheduled to take place between **23 June and 25 June 2022** from **02h00 to 16h00 each day**. However, the exercise may be postponed to take place at the same time on another date within the period 24 June to 7 July, excluding weekends.

#### 2. Location of Activity

The exercises will be undertaken in part of the Irish EEZ. Details of the indicated co-ordinates are set out in the table below. Please also see the charts set out in the Appendix.
