# ISORA Viking Marine Coastal Series 2026

## Supplemental Sailing Instructions

### 1. Organisation.

- 1.1. The 2026 ISORA Viking Marine Coastal Series is organised by the National Yacht Club (NYC) and ISORA.
- 1.2. Enquiries, correspondence and entries should be sent to:- ISORA Chairman chair@ISORA.org

### 2. Rules.

- 2.1. The event will be governed by the 'rules' as defined in *The Racing Rules of Sailing* (RRS) and the ISORA Notice of Race and the General Sailing Instructions 2026.
- 2.2. IRC rules part A, B & C shall apply to IRC racing.
- 2.3. Crew numbers shall be limited to the maximum number specified in the ISORA Notice of Race.
- 2.4. The requirements of Category 4 of the OFFSHORE SPECIAL REGULATIONS 2026-2027 apply to this event. Details of these are on the ISORA website.
- 2.5. In the event of conflict, this ISORA 2026 Supplemental Sailing Instructions (SSIs) will prevail. This changes RRS 63.7

### 3. Entries, Registration & Eligibility

- 3.1. Competitors for the 2026 ISORA Viking Marine Coastal Race must complete the entry form and pay the on-line event fee to ISORA – see the ISORA [web site](#)
- 3.2. Competitors must post their crew information in the **ISORA Crew Manager** app. All boats finishing the course must post their finish times on the app. – see the ISORA [web site](#). **This is mandatory and any boat failing to comply with this will not be given a result.**

ISORA will provide racing for the following classes of yachts and the Class divisions will be as follows: -

| Class       | Flag                                    | IRC                |
|-------------|---|--------------------|
| <b>Zero</b> | Numeral pennant 0                       | IRC >1.070         |
| <b>One</b>  | numeral pennant 1 (White with Red spot) | IRC 1.010 to 1.069 |
| <b>Two</b>  | numeral pennant 2                       | IRC < 1.010        |

These ranges may be changed at the discretion of the sailing committee.

- 3.3. Class Flags will be flown from the backstay of each competing yacht.
- 3.4. Yachts shall belong to or be chartered to and be under the control of a member of a yacht club affiliated to the IS or RYA or other equivalent national authority.
- 3.5. Entries and payment, shall be made on the Official Entry Form on the ISORA web site [>here](#).
- 3.6. The Event Committee reserves the right to refuse any entry and/or to ask any boats to complete further undertaking or declarations before accepting their entry.

### 4. Measurement

- 4.1. A valid and current IRC rating certificates must be presented on request to the Sailing Committee.

### 5. Compliance with Class Rules; Certificates

- 5.1. The Event Committee may inspect or measure any boat or personal equipment, at any time.

### 6. Changes in Sailing Instructions

- 6.1. Any change to the Supplemental Sailing Instructions or General Sailing Instructions will be posted by 18.30hrs on the day before it will take effect on the ISORA webs Site.

### 7. Schedule of Events.

- 7.1. The schedule is shown on the front page of this Supplemental Sailing Instructions.
- 7.2. There will be two starts as shown on the front page of this Supplemental Sailing Instructions.
- 7.3. The Event Officer may decide to have separate starts for each class or a group of classes. This will be announced by VHF (Channel 17) and flags.



- 7.4. The type of event will be a Coastal course and the course will be announced on the Friday prior to the Event on the web site. The expected duration of the race will be 3 hours.

## 8. Time of Start

- 8.1. The event start times will be as shown on the front page of this SSIs or as amended
- 10.55 Warning signal - Class flags (Numerals 0, 1 & 2) hoisted
  - 10.56 Preparatory Signal - Blue Peter hoisted
  - 10.59 Blue Peter down
  - 11.00 Start – Class flags down
- 8.2. The start may be broadcast on VHF Channel 17
- 8.3. The start may be cancelled if weather conditions are deemed by the Race Officer not to be appropriate.

## 9. STARTING LINE

- 9.1. The start line shall be located at the "Dun Laoghaire Outfall Buoy" and an adjacent committee boat flying a NYC burgee. It may not be anchored and may be using engine power to hold station. This changes RRS 62.1(a).
- 9.2. Prior to the start of each event boats are requested to obtain acknowledgement from the Event Committee.
- 9.3. The committee boat will maintain on the line for 10 minutes after the start. After that time, if any boats have not crossed the start line, "Dun Laoghaire Outfall Buoy" will become a mark on the course and boats must leave that mark to Port.

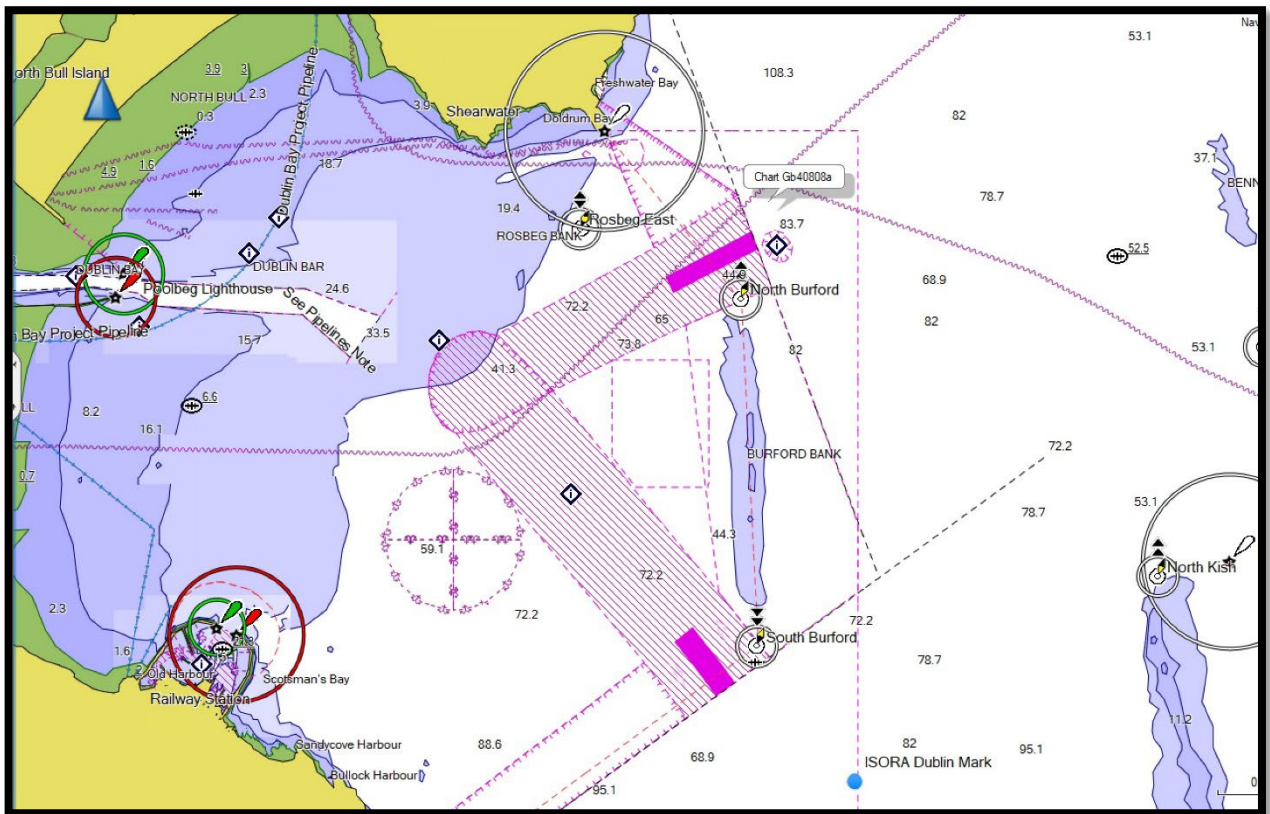
## 10. THE COURSE

- 10.1. The course attempts to have all boats finished by 14.00. The course is as follows:  
**STARTING LINE at Dun Laoghaire Outfall**  
**TBA**  
**FINISH LINE at Dun Laoghaire – between pier heads**
- 10.2. The Course will be published on the ISORA web site and announced to all entrants by text and Whatsapp by Mid-Day Friday 10<sup>th</sup> April 2026.
- 10.3. The course will be confirmed afloat to the competitors on **VHF CH 17** before the start.

## 11. TSS at South Burford

- 11.1. Please be aware that commercial vessels will be navigating in or approaching the traffic separation schemes in that vicinity; please be aware that Rule 10 of the International Regulations for the Prevention of Collisions at Sea requires that "a sailing vessel shall not impede the safe passage of a power-driven vessel following a traffic lane" it further states "(f) A vessel navigating in areas near the terminations of traffic separation schemes shall do so with particular caution" and "(h) A vessel not using a traffic separation scheme shall avoid it by as wide a margin as is practicable"

- 11.2. Please note that a Virtual Mark may be set to keep the fleet away from the South Burford Cardinal and this is defined as **ISORA Dublin Virtual mark (S)** N53 17.110 W6 00.100 (S)



## 12. Waypoints

- 12.1. Waypoints may be used as marks. If so, Rule 28 will be amended accordingly in accordance with the RYA / RORC Guidance – “Racing Around Waypoints” See website for details.
- 12.2. Evidence of rounding the “virtual” mark must be taken and may be requested by the Event Officer. This evidence may include:
- 12.2.1. Photographic (iPhone or similar) evidence of the yacht’s GPS showing its position at the mark.
  - 12.2.2. Yacht’s chart plotter track showing the yacht rounding the “virtual” mark. This must be transmittable to ISORA by email.
- 12.3. The onus of proof of having rounded the WAYPOINT mark will be with each yacht.

## 13. ISORA YB Tracker

- 13.1. All boats entered in the event will be fitted with the YB Tracker. The Skipper, accepting the units will be responsible for the replacement cost of the unit in a situation that the unit gets lost or damaged.
- 13.2. The units can be collected at the Marina Podium on Saturday 5th April at 08.30. Boats not based in Dun Laoghaire may collect their units from the Committee boat at the start line but only by prior agreement.
- 13.3. In order to set up the units all boats who are entered must declare on **Crewmanager** that they are racing by 12.00 on Thursday 9<sup>th</sup> April This declaration is a posting of the Boat and Crew details on the Crew Manager app. This is critical for the efficient running of the tracking system.
- 13.4. The trackers must be returned to Peter Ryan in National Yacht Club immediately after the event.
- 13.5. The event progress can be tracked by following the YB Tracking app for iPhones and Android. On downloading the app, the “Musto ISORA 2026 Series”.
- 13.6. Any queries relating to the Trackers should be dealt with by contacting Peter Ryan +353 87 2545037.



## 14. SHORTENED EVENTS

- 14.1. The event may be shortened at a mark and will be signalled by calling the fleet on **VHF Ch 17**.
- 14.2. If the fleet doesn't finish an event or shortened event, the event committee may take the result from the mark at which one third or more of the fleet round from the direction of the previous mark.

## 15. FINISH LINE

- 15.1. The finish line shall be between the Pier Ends at the Dun Laoghaire Harbour entrance.
- 15.2. The finish will be automatically recorded by the YB Tracker and the finish times will appear instantly on the app. There will be no Finisher on the line.
- 15.3. The finish time of the boat shall be recorded and posted on the CrewManager app.
- 15.4. The above procedure is mandatory and deemed to be a "Declaration" that the yacht has completed the course in accordance with the sailing instructions.
- 15.5. The time limit for the ISORA event will be 16.00 on Saturday 11<sup>th</sup> April
- 15.6. .
- 15.7. Boats finishing the course will be allocated their race positions. Boats retiring will be allocated lower positions based on the rounding time of the last mark that all the fleet rounded.

## 16. RETIREMENTS

- 16.1. Post the information on the **Crewmanager app** and the Whatsapp group.
- 16.2. For safety it is recommended to also inform the Coastguard by VHF.

## 17. Advertising

- 17.1. The racing will be a Category C event.
- 17.2. All yachts may be presented with a sponsor's flag or decals, which must be displayed at all times (if provided).

## 18. Scoring System

- 18.1. Scoring will be in accordance with Appendix A of the Racing Rules of Sailing and for ISORA using the ISORA series scoring.

## 19. Risk Statement

- 19.1. **THE DECISION WITH REGARD TO STARTING AND CONTINUING A EVENT LIES DEFINATIVELY WITH THE SKIPPER OF EACH BOAT AS HE / SHE ALONE IS AT ALL TIMES RESPONSIBLE FOR THE SAFETY OF HIS / HER OWN BOAT AND CREW**
- 19.2. RRS Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a event or to continue racing is hers alone."
- 19.3. Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
  - (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
  - (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
  - (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission;
  - (d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
  - (e) The provision of a event management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
  - (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances;
  - (g) They are responsible for ensuring that their boat is equipped and seaworthy so as to be able to face extremes of weather; that there is crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed and in date and is familiar to the crew.
  - (h) Their boat is adequately insured, with cover of at least £3,000,000 against third party claims.



## 20. Safety

- 20.1. Competitors must adhere to the requirements of **Category 4** of World Sailing Offshore Special Regulations 2026-2027 for this event. Details of these are on the ISORA website.

## 21. Personal Safety

- 21.1. RRS 1.2, 40 shall apply and it is the sole responsibility of the skipper to ensure that Life Jackets/Harness lines are carried for each member of the crew.

## 22. Apres-Race

- 22.1. It is proposed to have an Apres Race in the NYC immediately after finishing. A great opportunity to meet other skippers and crew and discuss the events if the race.

## 23. Prizegiving

- 23.1. The formal ISORA prizegiving will take place at the ISORA Annual Prizegiving Dinner to be held in the NYC on the 14<sup>th</sup> November 2026.
